

# VETPREV 7723 – Biosecurity, Emergency Response & Outbreak Investigation 2 credit hours – Spring 2020

## Class Time and Location: Monday (2:00-3:55 PM); A180 Sisson Hall

**Course description:** This course will provide an overview of biosecurity, with special emphasis on bioterrorism, preparedness, emergency response, risk assessment, and management of zoonotic and foreign animal disease outbreaks. The regulations and regulatory agencies involved in preventing and controlling foreign animal and zoonotic diseases will also be presented in this section. This course is appropriate for graduate or professional students in public health and other health sciences.

**Prerequisites:** Open to 1<sup>st</sup> (second semester), 2<sup>nd</sup>, or 3<sup>rd</sup> year students in the Professional Veterinary Medicine program, or Graduate standing.

**Class Format:** The teaching strategy of this course will be based primarily on lectures. The course will be presented by faculty from the Department of Veterinary Preventive Medicine and invited guest lecturers with expertise on specific course topic areas. Students are strongly encouraged to visit the course site on CARMEN (https://carmen.osu.edu/) regularly and print/download lecture materials in advance. Assigned readings should be used to expand on the information for specific topics.

## **Course Objectives:**

After completion of this course, the students should be able to:

- 1. Identify the basic principles of biosecurity, biocontainment, and biosafety.
- 2. Recognize the most important biological and bioterrorist threats to the US and determine how to assess those risks.
- 3. Be prepared to respond to an outbreak of a foreign animal and/or zoonotic disease at the local to international level.
- 4. Identify the most important regulations and laws pertaining to zoonotic/foreign animal diseases, and the agencies with the authority to set and enforce those laws.

- 3. Identify methods and programs utilized to prevent, control and/or eradicate zoonotic and foodborne diseases, including pre- and post-harvest intervention programs. (4)
- 4. Evaluate the integrity of emergency preparedness programs, including biosecurity, biocontainment, and natural disaster response plans. (5)
- 5. Review and apply methods for planning, initiating and conducting case and outbreak investigations of zoonotic and foodborne diseases. (6)
- 6. Recognize applicable regulations and laws governing zoonotic diseases, food safety and security, or foreign animal diseases, and the agencies with authority to enforce these laws. (7)
- 7. Define the role of epidemiology in maintaining human and animal health; and identify strategies in the design and conduct of surveillance, monitoring, and epidemiological studies that assess the prevalence and distribution of zoonotic and foodborne diseases. (8)
- 8. Analyze approaches for assessing and controlling environmental and biological agents and strategies for reducing risks to human and animal health, especially in agricultural settings. (9)
- 9. Use individual, team, and organizational learning opportunities for personal and professional development. (11)

**Text/Readings:** All required course materials and recommended readings will be accessible on the course Canvas site, as appropriate.

**Grading:** Grading will utilize the standard university grading scale (*note: final course grades are <u>not</u> rounded*):

For students taking the course to fulfill graduate program requirements in the area of specialization, a grade of B- or higher will be required in order to earn the credits. A grade below B- will require the student to repeat the course. A student who fails to earn a grade of B- or better on a second attempt will be considered to have failed this requirement. Credit hours for the repeated course shall in no case be counted more than once in meeting graduation requirements.

**Exams:** The written exams will be given in-class, and will be a combination of true/false, multiple choice, and/or short answer questions. *The second exam will not be cumulative.* In the event of a planned absence the day of the exam, the student should notify the team leader at least 24 hours in advance. If the student has an unplanned absence the day of the exam, he/she must contact the team leader as soon as possible. The decision on whether or not an exam may be made up will be on a case-by-case basis.

Assignments: Students are required to participate in and complete the Outbreak Response Case Study, including the core Incident Command System (ICS) training (IS-100.C and IS-200.C) and After Action Report. The Case Study will be a continuous (longitudinal) scenario that students will complete through the course Carmen page. Weekly "injects" will be revealed over the semester and will provide students with an opportunity to apply concepts presented in lectures. Further assignment instructions will be provided through the course Carmen page. As instructed, please upload completed materials (e.g., ICS completion certificates) to the course Carmen page by the provided deadline (ICS certificates: February 9 at 11:59pm; After Action Report: April 15 at 11:59pm). You will need a FEMA SID to complete the ICS evaluations to receive course certificates of completion – visit <a href="https://cdp.dhs.gov/femasid">https://cdp.dhs.gov/femasid</a> to apply for an SID if you do not have one. If you have previously taken either of these courses, you may select alternative courses (notify team leader first). See *Independent Study of Incident Command System* handout for more information.

**Carmen:** All relevant materials will be posted on Carmen, including the presentation handouts to be brought to each class.

## **Class Policies:**

#### **Electronic Device Policy:**

As a courtesy to others, the use of mobile devices such as cell phones, iPods, pagers, and other text messaging devices will not be permitted in class. If a student needs to keep their mobile device on vibrate during a class, please alert the instructor before class begins. Students are permitted to use computers or electronic notepads during class for note-taking and other class-related work only.
